Therefore, the State Government is directed to go ahead with the Counselling notification in respect of MBBS PG and Super Speciality Courses medical admissions.

The Respondents are further directed to notify the enhanced fee for the present academic year 2023-2024 at the rate of 15% as a tentative fee till the fixation of final fee as per the procedure under the provisions Act 20 of 2019 and Rules made there under, which is pending before the APHERMC".

As per the above Orders, the Government of Andhra Pradesh issued G. O. Ms. No. 123, HM&FW (C1) Dept., Dt. 10/08/2023 notified the fee structure for the academic year 2023-2024 by enhancing the rate of 15% on the existing fee of the academic year 2022-2023 which was notified in the G. O. Ms. No. 56, HM&FW C1) Dept., Dt. 29/05/2020 to the PG Medical and Dental Courses pending fixation of the final fee. The G.O. further stated that the fee structure notified is subject to outcome of the W. P. No's. 32975-33162 and 35090 of 2022.
